ABOUT INSTITUTE

ICMR-ROHCS-NIOH, Bengaluru under the aegis of the Indian Council of Medical Research, New Delhi is conducting its 5th batch of 3 months Associate Fellow of Industrial Health (AFIH) Course. During its 46 years of existence in southern region located at Bengaluru, the centre has conducted various training programmes on environmental & occupational health and trained many medical and allied professionals. The institute has various divisions such as Occupational Medicine, Industrial Hygiene & Toxicology, Air Pollution, Biochemistry, Respiratory Physiology, Ergonomics, Sociology, Statistics, etc. The laboratories are equipped with the modern instruments. The centre's/Institute Scientists are well qualified and have been trained in various disciplines of occupational health.



IMPORTANCE OF THE COURSE & ACCREDITATION

This is an industry need course in Occupational Health in Karnataka state, supported by the Department of Factories, Boilers, Industrial Safety & Health, Government of Karnataka. AFIH is a 3 months full time course in Industrial Health approved by the Directorate General Factory Advice Service & Labour Institutes (DGFASLI), Ministry of Labour & Employment, Govt. of India. On completion of the course, an examination will be conducted by DGFASLI and successful candidates will be awarded an AFIH certificate which will fulfil the requirements in terms of additional qualification for Factory Medical Officers as required under the Factories Act 1948, and the rules made there under. The 4 batches of 2016-17, 2018, 2019 and 2021 course inducted 100 (25 doctors from each batch) Medical Officers from various industries, academic, state and central governmental institutions and all of them completed their course successfully.



ELIGIBILITY FOR ADMISSION

- 1. MBBS Degree from an Institution recognized by the National Medical Council of India/Medical Council of India.
- 2. Completion of Internship.
- 3. Permanent Registration with the National Medical Council of India/ Medical Council of India/ State Medical Council. **Experience:**

As on 01 January 2023, after completion of compulsory internship, the applicant should have minimum of one year experience in registered factory, mines, dock works, construction work and plantation work under the respective statutes.

OR

Two years working experience in hospitals including self-practice. The period spent on higher studies (full-time NMCI/MCI recognised degree or diploma course only) after completion of MBBS Degree and internship with registration to Medical Council of India/State Medical Council shall be considered as equivalent to self-practice for fulfilling eligibility criteria for admission to AFIH Course, subjected to production of valid certificates.



WHO CAN APPLY @ ICMR-ROHC (S), BENGALURU

The applicants from the jurisdiction mentioned below shall apply to ROHCS (Code No 12) as per the permanent address (for non-working applicants) or place of work (for employed and self-practicing applicants) (Ref eligibility guidelines of DGFASLI). The applicants from UT/ states of Andaman & Nicobar Islands, Lakshadweep, Puducherry (Pondicherry), Andhra Pradesh, Telangana, Karnataka, Kerala, and Tamil Nadu are eligible.



DURATION OF THE COURSE & SEATS

Duration: 3 Months (1st March 2023 to 31st May 2023)

Number of Seats: 25 seats only. (Reservation policy & Procedures for SC/ST/OBC/PH/EWS categories laid down by the Government of India shall be followed).
