With reference to CBDT circular no. 04 dated 5.4.2023, for Clarification regarding deduction of TDS under section 192 read with sub-section (IA) of section 115BAC of the Income-tax Act, 1961.

All officials/Staff of the Institute are requested to inform about Income tax calculation for the finance year 2023-24, Assesment year 2024-25 may be calculated as per New Tax Regime or Old Tax Regime in the Annexure 'A' and submit the same to Account Section on or before 15.06.2023.

If information not received by officials/staff by due date, it will be presumed that such official/staff is willing to continue in the default tax regime (i.e New Tax Regime). Accordingly, TDS under section 192 shall be deducted from the salaries.
