No representations shall be entertained after 21.09.2023 (11:59 PM). Please note that No Document attached with the representation shall be considered for eligibility.

The candidates who have been declared as Eligible are to note that they are PROVISIONALLY ELIGIBLE and their Eligibility is subject to the verification of their Essential Qualification, Experience, Category etc. as required vide the above stated notification/advertisement. Merely fulfilling the essential qualification and requisite experience by the candidate and declaring as Eligible does not confer any right to be called for the written test and for appointment to the post applied for, in case of selection. The Eligibility criteria shall be checked at every stage of the recruitment.

Eligible candidates shall receive admit card along with syllabus through email shortly and tentative dates of examination shall be from 25th October 2023 to 25th November 2023.

The Director-in-charge, NIOH may:
