General Overview of the Institute:

- Brief description of functions: Established in 1984 as the Desert Medicine Research Centre (DMRC), Jodhpur, the institute was renamed the *ICMR-National Institute for Implementation Research on Non-Communicable Diseases (ICMR-NIIRNCD)*, Jodhpur, in December 2019. The institute is dedicated to conducting high-quality implementation research focused on non-communicable diseases (NCDs), developing Behaviour Change Communication (BCC) materials, and designing innovative models to address the risk factors associated with various NCDs. With proven expertise in bridging research and public health through implementation research, its focus areas include: NCDs such as cardiovascular diseases, diabetes, cancers, chronic respiratory diseases, and mental health; communicable diseases including tuberculosis, vector-borne diseases, and emerging infections; maternal and child health (MCH) covering nutrition and reproductive health; and other domains such as haemoglobinopathies, environmental health, injury and trauma, and digital health applications.
- The institute is equipped with a well-established Epidemiology Division and IT & GIS Lab. Besides, there are Biotechnology, Biochemistry, Microbiology, and Virology units.
- The Priority Areas of the Institute are:
 - 1 Implementation research for effective delivery of services under Ayushman Bharat – Comprehensive Primary Health Care Services (CPHC) and Pradhan Mantri Jan Arogya Yojana (PM-JAY).
 - 2 Implementation Research for strengthening the National Programme for Prevention & Control of Cancer, Diabetes, Cardiovascular Diseases & Stroke (NPCDCS) and other programmes for preventing and controlling selected NCDs.
 - 3 Development of comprehensive care models for sickle cell disease among the tribal population
 - 4 IT-based interventions to augment national health programmes at the primary health care level
 - 5 Impact of air pollution on respiratory diseases and strategies for risk reduction
